

FAQs of Online Summer School on Commercial Litigation

1. What is the curriculum for Course 1?

Course 1— “Foundations of Commercial Litigation & Corporate Disputes”—runs from **June 4 to June 21, 2025** and comprises **14 lectures**. In this course you will learn about:

- **Foundations of commercial litigation:** commercial vs. civil disputes, roles of litigators and in-house counsel, key provisions of the Commercial Courts Act, 2015, and drafting pleadings for commercial suits
- **Dispute resolution forums:** hierarchy of commercial courts, tribunals (NCLT/NCLAT, DRT/DRAT) and regulatory bodies (SEBI, RBI), cross-border judgment enforcement, and handling jurisdictional challenges
- **Contractual & corporate disputes:** breach of contract remedies (specific performance vs. damages), force majeure and termination clauses, liquidated damages vs. penalty, shareholder remedies, oppression & mismanagement, and M&A dispute resolution

Each module features **practical drafting exercises, quizzes, and guest lectures** from leading practitioners to build hands-on skills alongside doctrinal knowledge.

2. What is the curriculum for Course 2?

Course 2— “Financial, Regulatory and Advanced Litigation Strategies”—runs from **June 22 to July 18, 2025** and comprises **19 lectures**. In this course you will learn about:

- **Insolvency & bankruptcy litigation** (CIRP under IBC, NCLT/NCLAT jurisdiction, liquidation plans, DRT/SARFAESI)
- **Debt recovery forums** (bank guarantees, letters of credit, avoidance transactions)
- **Competition & antitrust disputes** (CCI investigations, merger control, leniency applications)
- **Securities & white-collar crime** (SEBI investigations, insider trading, corporate fraud, PMLA)
- **Litigation strategy, ADR & international commercial disputes** (pre-trial motions, injunctions, arbitration, enforcement of foreign awards)

Each module features **practical drafting exercises, quizzes,** and **guest lectures** from leading practitioners to build hands-on skills alongside doctrinal knowledge.

3. Which institution is conducting the course and is certification provided?

This programme is offered by **Manupatra Academy**, in collaboration with top litigators and academics from institutions such as IIT Delhi, MNLU Mumbai, RHP Partners, Qess Corp, and others. Upon completion of each course (or both), you will receive an **e-Certificate of Completion/Participation** from Manupatra Academy.

4. I'm a first-year law student. Will this course help me secure internships at law firms?

The Summer School sharpens practical skills such as pleading drafting under the CPC, corporate dispute analysis, IBC practice, SEBI litigation and ADR which are highly valued by law firms. Demonstrating these abilities on your CV can make you a stronger candidate for internships.

5. I'm pursuing BBA with CA intermediate. Can I apply even though it's not a beginner law course?

Absolutely. While the Summer School is tailored for law students and professionals, anyone with a foundational understanding of legal terminology can benefit. Your BBA/CA background will help you grasp financial and regulatory modules quickly.

6. I completed my LLB in 2024 and have 17 years of finance experience. How will this course build my skill set?

Your extensive financial background will be an asset. Course 2's focus on insolvency, debt recovery, securities regulation and white-collar crime will broaden your expertise in commercial litigation.

7. Are the lectures live or pre-recorded? Are timings flexible? Is any physical attendance required?

- **Format:** Live, instructor-led classes **Wed–Fri (7:30–8:30 PM)** and **Sat–Sun (11–12 PM)** with recordings available for later viewing.
- **Flexibility:** You must join the live session or watch its recording; there is no on-demand scheduling beyond these slots.

- **Mode:** Entirely online—no physical presence required.
- **Certification:** E-Certificate issued upon completion.

8. Will there be any test for the certificate?

You won't face a formal end-of-course exam. However, you will complete **practical assignments, drafting exercises and quizzes** throughout the modules. Satisfactory participation earns you the e-Certificate.

9. Does the programme recommend law firms or assist with job placements?

The Summer School focuses on **building your litigation and deal-making skills**. While it does not include formal placement services or firm recommendations, your strengthened skill set after the completion of this course can enhance your recruitment prospects.

10. How long can I access the recordings?

Recordings are accessible **throughout the duration of the programme**, and remain available until the course officially concludes. Access details and any post-course viewing window will be communicated before the start date.
