The legal profession today spans far beyond traditional courtroom roles. Below is a structured overview of major legal career categories along with their specific roles.



## Litigation & Courtroom Practice

<b>Advocate (Litigator)</b>	Represents clients in civil and criminal cases before courts.	Case preparation, drafting pleadings, oral arguments, evidence handling.	Independent practice, law firms, courts.	Advocacy, legal drafting, research, client management.
<b>Public Prosecutor</b>	Represents the State in criminal prosecutions ensuring justice is served.	Examine witnesses, present evidence, prepare charges, argue in court.	Government offices, courts.	Criminal law, trial advocacy, drafting, ethics.
<b>Defense Counsel</b>	Defends individuals accused of crimes ensuring their rights are protected.	Develop defence strategies, cross examination, filing petitions.	Private practice, legal aid, courts.	Litigation skills, empathy, negotiation, research.



# Judiciary & Government Service

<b>Judge / Magistrate</b>	Presides over cases, interprets laws, and delivers judgments.	Hear cases, review evidence, write judgments, manage proceedings.	District courts, High Courts, Supreme Court.	Judicial reasoning, impartiality, judgment writing, procedural law.
<b>Judicial Clerk</b>	Supports judges with legal research and drafting.	Research precedents, draft orders and briefs, prepare case summaries.	Courts, tribunals.	Research, drafting, analysis, attention to detail.
<b>Judge Advocate General (JAG) Officer</b>	Military lawyer handling courts-martial and service law matters.	Advising armed forces, prosecuting or defending courts-martial, drafting opinions.	Indian Army, Navy, Air Force legal wings.	Military law, international law, advocacy, discipline.
<b>Government Legal Officer</b>	Provides legal advice to ministries, departments, and agencies.	Draft contracts, vet policies, represent State in disputes.	Government departments, PSUs.	Policy analysis, legislative drafting, negotiation, advisory.
<b>PSU Legal Officer</b>	Manages legal issues for public sector companies.	Draft agreements, ensure compliance, litigation management.	Public Sector Undertakings.	Contract drafting, compliance, corporate law knowledge.

<b>Corporate Lawyer</b>	Advises companies on mergers, acquisitions, contracts, and governance.	Draft contracts, due diligence, advisory, negotiations.	Law firms, corporates, consultancies.	Corporate law, drafting, commercial awareness, negotiation.
<b>In-House Counsel</b>	Handles company's internal legal matters and compliance.	Review contracts, litigation management, regulatory compliance.	Companies, startups, MNCs.	Compliance, contract management, risk analysis, business acumen.
<b>Compliance Officer</b>	Ensures organisations comply with legal and regulatory frameworks.	Policy drafting, compliance audits, monitoring, reporting.	Corporates, banks, financial institutions.	Regulation knowledge, risk assessment, reporting.
<b>Banking &amp; Insurance Lawyer</b>	Advises on financial regulations and litigation.	Draft loan agreements, handle recovery cases, advise on compliance.	Banks, NBFCs, insurance companies.	Finance law, RBI norms, KYC/AML, drafting.

<b>Cybersecurity &amp; Privacy Lawyer</b>	Advises on IT, privacy, and cybersecurity laws.	Draft privacy policies, advise on breaches, ensure compliance.	Tech firms, law firms, regulators.	Data privacy, IT law, compliance, advisory.
<b>Environmental Lawyer</b>	Handles environmental compliance and disputes.	Litigate PILs, advise corporates on compliance, draft EIA reports.	Courts, NGOs, corporates.	Environmental law, advocacy, drafting, policy analysis.

<b>Legal Designer</b>	Uses design thinking to make legal information and processes more accessible and user-centric.
